Outcome Statement

Children have a fundamental right to care and protection. At Puhinui School tamariki have the right to a safe environment where they can thrive, belong and achieve to the best of their ability.

Response to Child Abuse

All staff members (including contractors and volunteers) are expected to be familiar with this policy, its associated procedures and protocols and abide by them.

Advice will be sought through appropriate agencies in all cases of suspected or alleged abuse. In line with Section 15 of the Oranga Tamariki Act 1989, any person in our school/kura who believes that any child or young person has been or is likely to be harmed (whether physically, emotionally or sexually), ill-treated, abused, neglected or deprived must follow school procedures and may also report the matter to a social worker or the local Police.

Delegations

Although ultimate accountability sits with the board, the board delegates to the principal responsibility for developing the appropriate child safety procedures at the school and that they ensure the relevant legislative requirements are complied with.

Expectations and limitations

The principal must:

develop appropriate procedures to meet child safety requirements as required and appropriate to the school

required and appropriate to the school
At all times the respect and protection of a child is handled with extreme care and confidentiality. Appropriate information is shared within the application of the law and the privacy act.
comply with relevant legislative requirements and responsibilities
make this policy available on the school's internet site or available on request
ensure that every contract or funding arrangement that the school enters into requires the adoption of child protection policies where required
ensure the interests and protection of the child are paramount in all circumstances
recognise the rights of family/whānau to participate in the decision making about their children

ensure that all staff are able to identify the signs and symptoms of potential abuse and neglect and deal with disclosures by children and allegations against staff members and are able to take appropriate action in response
support all staff to work in accordance with this policy to work with partner agencies and organisations to ensure child protection procedures are understood and implemented
promote a culture where staff feel confident they can constructively challenge poor practice or raise issues of concern without fear of reprisal
consult, discuss and share relevant information with the board or designated person in line with our commitment to confidentiality and information-sharing protocols in a timely way regarding any concerns about an individual child
seek advice as necessary from NZSTA advisers on employment matters and other relevant agencies where child safety issues arise
make available professional development, resources and/or advice to ensure all staff can carry out their roles in terms of this policy
ensure that this policy forms part of the initial staff induction programme for each staff member.
Ensure the safety checks are carried out

Procedures/supporting documentation

Definition

Child abuse: Includes physical, emotional and sexual abuse as well as neglect which is the direct consequences of a deliberate act or omission by an adult and which has the potential or affect of serious harm to the child.

Child neglect: Failure or omission to care for a child. This can be physical, emotional, medical, educational and a lack of supervision.
